项目概况: 锦州 23-2 油田开发推荐方案拟新建 2 座 8 腿热采中心平台 JZ23-2 CEPA 和 JZ23-2 CEPA 和 JZ23-2 CEPB,设置 80 人生活楼和 180 修井机,JZ23-2 CEPA 和 JZ23-2 CEPB 之间通过 2km 的海管和海缆连接。热采井流物在 JZ23-2CEPA 和 JZ23-2CEPB 处理成部分含水原油后,在 JZ23-2CEPB 汇集经新建 JZ23-2CEPB 至 JZ9-3CEPD 海底管道送至 JZ9-3CEPD 处理成合格原油后,送至 JZ9-3 储油沉箱储存外输。油田依托锦州 9-3 油田联网供电,并在 JZ23-2CEPB 平台增设 2 台原油电站补充电力不足。

Project Summary: It is proposed to build two eight-leg thermal production center platforms JZ23-2 CEPA and JZ23-2 CEPB, set up 80 people living buildings and 180 workover RIGS. JZ23-2 CEPA and JZ23-2 CEPB are connected by 2km sea_

pipe and sea cable. After being processed into partially water-bearing crude oil by JZ23-2CEPA and JZ23-2CEPB, the flow from thermal recovery Wells is collected by JZ23-2CEPB and sent to JZ9-3CEPD for qualified crude oil treatment through the newly built submarine pipeline from JZ23-2CEPB to JZ9-3CEPD, and then sent to JZ9-3 oil storage caisson for storage and transportation. The oilfield relies on Jinzhou 9-3 oilfield for networked power supply, and two additional crude power stations are added on JZ23-2CEPB platform to supplement the power shortage.
